

Public offer

In accordance with Article 395 of the Civil Code of the Republic of Kazakhstan (hereinafter referred to as the CC RK), this public offer is an offer by the autonomous educational organization "Nazarbayev Intellectual Schools" (hereinafter referred to as the Contractor), represented by the Deputy Chairman of the Board, Kabdykarimova Zh., acting on the basis of power of attorney No. 129 dated December 24, 2025, to conclude an agreement for the provision of services for organizing participation in the International Research-to-Practice Conference XV NIS Conference 2026 (hereinafter referred to as the conference) (hereinafter referred to as the Agreement) with any individual who accepts this offer under the terms specified below (hereinafter referred to as the Customer), collectively referred to as the Parties, have agreed to the following:

1. General Provisions

1.1. The offer is considered fully and unconditionally accepted by the Customer and the Contractor signed by the Parties from the moment when the Customer perform all the following actions:

- a) applying for participation in the conference in electronic format on the website at <https://conf.nis.edu.kz/en> (hereinafter – the website);
- b) paying a registration fee for participation in the conference in the amount specified on the website.

1.2. The Agreement is concluded with the receipt of the registration fee to the Contractor's accounts.

1.3. In accordance with the paragraph 1, clause 397 of the CC RK, when the offer contains a deadline for acceptance, the Agreement is concluded when the acceptance is received by a person sent the offer within the period specified therein, including the conditions for payment of the Contractor's services.

2. Subject of the Agreement

2.1. The Contractor undertakes to provide services on the organization of the participation of the Customer in the conference, and the Customer undertakes to pay the registration fee on the website and take part in the conference.

3. Registration fee and payment

3.1. The registration fee for participation in the conference is paid on the website via the internet acquiring of the Contractor's accounts in accordance with the terms of this Agreement. The amount of the registration fee includes VAT 12%.

3.2. Registration fee is accepted only in non-cash form.

3.3. In case of the Customer's refusal to participate in the conference, the Contractor must be notified in writing via email at info@nis.edu.kz, conference@nis.edu.kz for 30 (thirty) calendar days prior to the conference, by sending a request for the return of the registration fee as well as payment receipt and bank statement indicating the twenty-digit settlement account number. The amount of registration fee will be refunded by deducting of the Contractor's bank charges.

4. Duties of the Parties

4.1. The Contractor must:

- 4.1.1. Provide an opportunity to participate in the conference;
- 4.1.2. Timely inform about the changes in the program of conference on the website;
- 4.1.3. In case of changing the date of the conference, notify the Customer by publication on the website no later than 5 (five) calendar days prior to the conference.

4.1.4. In case of a request for a refund of the registration fee submitted for 30 (thirty) calendar days prior to the conference, the amount of registration fee will be refunded by deducting of the Contractor's bank charges.

4.2. Customer must:

4.2.1. Pay for the services in the manner prescribed by the Agreement;

4.2.2. Ensure the attendance at the conference;

4.2.3. In case of refusal to participate in the conference, notify the Contractor for 5 (five) calendar days prior to the conference.

5. Liability of the Parties

5.1. For improper performance of the Agreement the Parties are responsible in accordance with the current legislation of the Republic of Kazakhstan.

6. Other conditions

6.1. The Agreement shall come into effect upon adoption of this public offer by the Customer and is valid until the execution by the Parties of their obligations.

6.2. The Contractor may engage third Parties to fulfill its obligations under the Agreement act without the consent of the Customer.

6.3. The Agreement may be terminated in the manner prescribed by the current legislation of the Republic of Kazakhstan.

6.4. In case of differences or disputes on matters arising from or relating to the Agreement, the Parties shall endeavor to resolve through negotiations any disputes arising from the Agreement or in connection with its implementation.

7. Final Provisions

7.1. This public offer shall come into effect upon its publication on the website and is valid up to the start of the conference.

7.2. The Contractor reserves the right to amend the terms of this public offer or to withdraw a public offer at any time at its discretion. The effective date of the changes of this public offer is the date of publication of new edition on the website or information on the withdrawal of the offer.

7.3. By accepting the conditions of this offer, the Customer confirms concluding the Agreement voluntarily and agrees to all conditions set forth in the offer.

7.4. This public offer is made in a unique copy and published on the website.
